5. Business to be Discussed

5.1 Communication and Work Plan Update

Stacey Jeffery provided members with a copy of the up-to-date Communication/Work Plan for information as to where the video series is at in terms of execution. Overall, the video series is off to a great start in terms of website preparations, news release, community calendar, introduction video, and social media posts.

Stacey reviewed the Communication/Work Plan and indicated the various advertisements that were prepared. It was noted that the Exeter Lakeshore Times Advance featured the video series in their print in June 2021.

It was discussed that the dates indicated on the Communication/Work Plan may be altered slightly depending on scheduling of other municipal items or priorities that may arise.

Chair Boles inquired whether or not there are concerns with the video series progress and schedule. Stacey Jeffery noted that creating the video takes a lot of staff time as well as each member will be required to spend time preparing their video description, outline of their video, coordinating speakers. It is important to be mindful of time spent on the video series and to strive to have the videos recorded as soon as possible to allow for time to create and approve the video. Video approval by the Committee have to be done in advance of the release date which may have the Committee meeting monthly, unless multiple videos are prepared to be approved. If monthly meetings are required, they can be focused on approving the video and any pressing matters that may arise.

Chair Boles asked for clarification regarding the approval of the videos and what the format of the meeting must be. Stacey advised that the Clerk

may have to be consulted for direction however the preference is that the Committee approves all videos during a formal scheduled meeting to ensure the video content is vetted by the Committee prior to official release, which in turn will be brought to South Huron Council through the meeting meetings. Member Vaughan agreed that the Committee should continue to meet during a formal scheduled meeting for approval of videos moving forward. These meetings can be focused on video approval and short in nature.

## 5.2 Member Video Updates

Stacey Jeffery provided an update on the Trees, Stewardship, Grants and Preparing for the Future and Low Impact Development/ Green Infrastructure video to members. The Trees, Stewardship, Grants and Preparing for the Future video has been finalized and ready to be released, pending Committee approval in agenda item 5.3. All recording has been completed for the Low Impact Development/Green Infrastructure video and will be created and sent to members within the next few weeks.

Member Munn provided an update on the Strip and Minimum Tillage video. Mike Strang is prepared to have his information ready for the August release date. Member Munn will confirm that the recording can take place as soon as possible so the video can be created and approved.

Member Vaughan provided an update to members on the Energy Efficiency video. An outlined for the video has been created. Further updates on progress to come.

Chair Boles provided an update to members on the Waste Reduction video. Bluewater Recycling Association, Eco Exeter and Wholesome Pastures have all confirmed. Stacey Jeffery provided an overview of the hierarchy of waste reduction decision making and that this video will follow this process (i.e., do you need it? is there a reusable alternative? can it be recycled? is it going in the appropriate waste stream?).

Member Keller provided an update to members on the Water and Wastewater video. Matt Pearson is confirmed. Further updates on progress to come.

Chair Boles provided an update on the Home Flood Protection video. Cheryl Evans from the Intact Centre for Climate Adaptation and Larry Freiburger from A.E.T have been confirmed. Chair Boles is meeting with Cheryl to discuss the video and begin to create the outline for the video.

### 5.3 Trees, Stewardship, Grants and Preparing for the Future

Chair Boles indicated that the first video was well done and sets the bar high for the remainder of the videos. The content was very useful and what was expected for the video series.

Member Vaughan identified a few minor issues that Stacey will address prior to finalizing the video. It was identified that the video was very well done and included a lot of relevant information and will reach a wide audience within our community.

The Committee expressed thanks to Ian Jean from the Ausable Bayfield Conservation Authority for his participation in the video series.

Chair Boles also indicated that the Sustainable Huron meeting occurring on June 25, 2021 have received our news release for the video series and will mention it at the meeting.
