IMPAIRED DRIVER STOPPED IN EXETER

(SOUTH HURON, ON) – A 58-year-old from Grand Bend will be making a trip to court in a few weeks to answer to charges of Impaired Operation & Over 80.

On May 22, 2019 at approximately 8:17 p.m. a Huron County Ontario Provincial Police (OPP) officer received a traffic complaint of a possible impaired driver near the hospital in Exeter. A few minutes later the investigating officer observed the suspect vehicle travelling northbound on William Street near Huron Street. A traffic stop was conducted and the officer noted the driver was displaying signs of impairment. A Standard Field Sobriety Test (SFST) was conducted and the driver failed. The driver was arrested for impaired operation and was transported to the Exeter OPP Detachment for breath tests.

Two samples of the driver's breath were obtained by the qualified Intoxilizer Technician and both samples were determined to be over the legal limit.

As a result, Scott MACGREGOR, 58 years of age from Grand Bend has been charged with Operation While Impaired and Operation While Impaired – Blood Alcohol Concentration 80 Plus. The accused has since been released from custody with a court appearance scheduled for June 24, 2019 at the Ontario Court of Justice – Goderich.

ANNUAL LAW ENFORCEMENT TORCH RUN RETURNS TO HURON COUNTY

(HURON COUNTY, ON) - The Ontario Law Enforcement Torch Run will be making its return into Huron County next week and with that Huron County Ontario Provincial Police (OPP) & Special Olympics Ontario invite you to participate in this annual event.

Special Olympians, police officers, family members, friends and community supporters from all over Huron County will run, walk, stroll together on **Tuesday, June 11th, 2019** in an effort to increase awareness and raise funds for Special Olympics Ontario.

2019 marks the 32nd anniversary of the Ontario Law Enforcement Torch Run (LETR). The Ontario Law Enforcement Torch Run is the largest public awareness vehicle and grass-roots fundraiser for Special Olympics. Torch Run Ontario raised \$2.3 million dollars in 2018 for Special Olympics Ontario

After completing the final leg in Goderich participants and supporters will meet back at McGee Motors located on Suncoast Drive East in Goderich for a celebration BBQ.

Bus transportation will be provided free of charge from Goderich to Wingham. Please arrive at the Goderich OPP Detachment located on Courthouse Square prior to the 8:00 a.m. departure time.

TRAFFIC STOP RESULTS IN LARGE SEIZURE OF CASH & FENTANYL

(HURON COUNTY, ON) – Huron County Ontario Provincial Police (OPP) has put a significant dent into the local supply of fentanyl following an investigation conducted by members of the Huron-Perth OPP Community Street Crimes Unit (CSCU).

Just after 7:30 p.m. on Sunday, June 2, 2019 an officer with the Huron-Perth OPP Community Street Crimes Unit (CSCU) conducted a traffic stop of a car on Huron Street West in Exeter.

The driver verbally identified himself to the officer however upon checking the name and date of birth provided, the officer noted some obvious discrepancies in the identity. As such the driver was placed under arrest for obstructing a peace officer.

Following the driver's arrest a search of the driver and vehicle was conducted. This search resulted in police seizing a large quantity of suspected purple fentanyl. The estimated street value of the seized fentanyl is nearly \$21,000. Additionally, officers located and seized over \$20,000 in Canadian currency.

Upon confirming the actual identity of the accused, police determined the driver held a suspended driver's licence and was also wanted on outstanding offences by Waterloo Regional Police Service.

Following this traffic stop, on Wednesday, June 5, 2019 members from the Ontario Provincial Police (OPP) Community Street Crime Unit (CSCU) and Huron County OPP executed a search warrant at a residence located on Mill Street in the Municipality of South Huron, Huron County.

As a result of the execution of the search warrant, police seized a quantity of Buprenorphine - a Schedule I Substance, trace amounts of fentanyl, a prohibited weapon (push-dagger style knife), digital scale and drug packaging materials.

Philip WALSH, 38 years of age from South Huron has been charged with:

- Obstruct Peace Officer
- Personation with Intent to Avoid Arrest
- Possession for the Purposes of Trafficking (Fentanyl)
- Possession for the Purposes of Trafficking (Buprenorphine)
- Possession of a Schedule I Substance - (Fentanyl)
- Possession of Proceeds of Property Obtained by Crime
- Driving While Under Suspension
- Unauthorized Possession of a Weapon
- Fail to Comply with Recognizance – Four Counts

The accused remains in custody with a court appearance scheduled for June 14, 2019 at the Ontario Court of Justice – Goderich.

OFFICERS USE NALOXONE TO HELP SAVE TWO LIVES

(HURON COUNTY, ON) – Huron County Ontario Provincial Police (OPP) is warning the public of the serious dangers of the misuse and abuse of opioids, in particular fentanyl. Huron OPP officers and paramedics from Huron County Paramedic Services are credited with saving two lives yesterday in Huron County after responding to two unrelated suspected fentanyl overdoses.

The first occurrence took place just after 8:00 a.m. on Monday, June 18, 2019 when police received a call to attend an address located east of Bayfield on Wildwood Line for a 25-year-old male in medical distress.

The second occurrence took place at approximately 4:00 p.m. when officers responded to a residence located on King Street in Hensall to assist an 18-year-old female that was in medical distress.

In both instances officers provided life-saving first aid by administering Naloxone. Upon administering Naloxone to the subjects they both began to breathe and both individuals regained consciousness. Both subjects were then transported to local hospitals for further care.

Huron County OPP is reminding the public of the dangers of opioid based drugs including fentanyl. Please understand fentanyl is a very potent and dangerous opioid pain reliever. You can't see, taste, or smell fentanyl and few grains can be enough to kill you.

"In both instances yesterday, citizens remained on scene and contacted 9-1-1 immediately. Officers and paramedics quickly responded to the scene, correctly assessed the situation and utilized their training to help save two lives. The dangers are very real and we are very concerned about the safety of our citizens. Preserving life is first and foremost. If you need help please make that call".

If you suspect someone is overdosing or is in medical distress don't delay, contact 9-1-1 immediately. Remember, the OPP supports Canada's Good Samaritan Drug Overdose Act that provides protection from charges for individuals at the scene of a drug overdose for simple drug possession. Please don't fear charges, stay at the scene and stay with a victim in the event of an overdose.

OVER THE LEGAL LIMIT IN EXETER

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) has charged a 26-year-old from Exeter with Over 80 following a traffic complaint that took place in Exeter over the weekend.

At approximately 2:15 a.m. on Saturday, June 22, 2019 Huron OPP officers received a call about a possible impaired driver that was asleep behind the wheel of his vehicle while in the drive-thru of a restaurant.

While en-route to the dispatch address, the suspect vehicle went mobile so officers began patrolling around the area for the suspect vehicle. Within a few minutes an officer observed the suspect vehicle pulling into a laneway at the Norwood Village Trailer Park. Upon speaking with the driver the investigating officer noted the driver had consumed some alcohol. As a result, a demand was made for him to provide a sample of his breath into an approved screening device. The driver complied and he registered a fail on the roadside. He was placed under arrest and was transported to the Lucan OPP Detachment for breath tests. The driver complied and supplied two breath samples of his breath to the qualified Intoxilizer Technician; both tests were above the legal limit.

Graham BEDARD, 26 years of age, from Exeter has been charged with Operation While Impaired – Blood Alcohol Concentration (BAC) 80 Plus. He was later released from custody with a court date scheduled for July 25, 2019 at the Ontario Court of Justice – Goderich. His vehicle was impounded and his licence has been suspended for an automatic 90 days.

IMPAIRED DRIVER ARRESTED AFTER TRYING TO EVADE POLICE

(EXETER, ON) - On July 13, 2019, at approximately 1:30 a.m., members of the Ontario Provincial Police (OPP), South Huron detachment responded to the report of a possible impaired driver that observed traveling towards Exeter.

OPP officers responded quickly and the driver was located trying to hide in a restaurant parking lot. Officers determined that her ability to operate a motor vehicle was impaired. She was arrested and transported to the Exeter OPP detachment for further testing.

Patricia GOULD, 53-years-old, of Lucan Biddulph was charged the following;

- Operation while impaired - blood alcohol concentration (80 plus)

Her driver's licence was seized and a 90 Administrative Driver's Licence Suspension (ADLS) was imposed. The vehicle was towed and impounded.

She is scheduled to appear in the Ontario Court of Justice, Goderich on September 26, 2019 to answer the charges.

If you suspect someone is driving while their ability to operate a motor vehicle is impaired, either by drug or alcohol, call police at 911 to report it.

IMPAIRED DRIVER ARRESTED AFTER STRIKING A MAILBOX AND A PARKED CAR

(EXETER, ON) - On July 13, 2019, at approximately 5:45 p.m., members of the Ontario Provincial Police (OPP), South Huron detachment responded to the report of a possible impaired driver that had struck several items and then pulled into a restaurant in Exeter.

OPP officers responded quickly and the driver was located. Officers determined that his ability to operate a motor vehicle was impaired. He was arrested and transported to the Exeter OPP detachment for further testing.

Yves LEONARD, 57-years-old, of London was charged the following;

- Operation while impaired - alcohol
- Operation while impaired - blood alcohol concentration (80 plus)

His driver's licence was seized and a 90 Administrative Driver's Licence Suspension (ADLS) was imposed. The vehicle was towed and impounded.

He is scheduled to appear in the Ontario Court of Justice, Goderich on July 29, 2019 to answer the charges.

If you suspect someone is driving while their ability to operate a motor vehicle is impaired, either by drug or alcohol, call police at 911 to report it.

FIREWORKS SAFETY THIS CANADA DAY LONG WEEKEND

(HURON COUNTY, ON) – Huron County Ontario Provincial Police (OPP) has a Canada Day Fireworks safety reminder. Your safety and the safety of others around you must be priority number one when handling fireworks.

As we approach the Canada Day long weekend the safest way to enjoy fireworks is to attend an exhibition fireworks show handled by professionals. One such amazing display will be held in Goderich

on Sunday, June 30, 2019. These displays are planned for and overseen by a trained, certified professional. If you choose to hold a family fireworks show with "common fireworks" sold to consumers, remember that injuries almost always result from improper handling and a disregard for safety.

The OPP & Canada Safety Council would like to share some fireworks safety tips from purchasing and setting up, to the fireworks show and proper disposal. Regulation alone cannot protect the public. It must be combined with personal responsibility and awareness.

- Follow the laws and regulations regarding the use of fireworks.
- Purchase your fireworks from a reliable source that sells products meeting safety standards.
- Stay away from illegal explosives or firecrackers and do not improvise and make your own fireworks.
- Always read the Instructions, cautions and warnings on each firework item.
- Store unused fireworks in a closed box away from the firework being lit and do not smoke around the fireworks.
- Set up outdoors in a clear, open space. Light fireworks on a hard, flat and level surface.
- Check the wind and have the wind blowing away from spectators.
- Spectators should be at least the safety distance written on the fireworks label away from the display, keeping constant supervision on children.
- Have a bucket of sand, supply of water and a working fire extinguisher on hand.
- Only adults should handle the fireworks. If you are impaired by alcohol or drugs do not handle the fireworks.
- Light only one firework item at a time.
- Wear protective eye glasses and gloves. Light at arm's length and then stand back.
- Never lean over the fireworks and keep hair and clothes away from fire sources.
- Never attempt to re-light a "dud" or defective firework.
- Never hold a lighted firework item in your hand.
- Sparklers should be immersed in a bucket of sand to cool down after burning out, as they remain very hot for some time.
- Fireworks should be disposed of safely and properly.

CANADA DAY LONG WEEKEND WRAP UP

(HURON COUNTY, ON) – The 2019 Canada Day Long Weekend focus for Huron County Ontario Provincial Police (OPP) was to ensure safe roads and waterways by providing high visibility, education & enforcement.

Huron OPP is very pleased to report there were no fatalities on our roadways or waterways over the long weekend. In total, there were 15 motor vehicle collisions reported to the OPP that were investigated within Huron County. The majority of these crashes were minor property damage crashes.

Out on the roads officers charged a total of **78** drivers with speeding, one for failing to wear a seatbelt, three with distracted driving, three with liquor related charges, and two were charged with stunt driving offences for racing their vehicles in excess of 50 km/h over the limit. Several Reduce Impaired Driving Everywhere (RIDE) checks took place over the weekend as well. One driver was served with an alcohol warn-range suspension however Huron OPP is very pleased to report no drivers were charged with Impaired Driving.

Out on Lake Huron, Huron OPP officers conducted marine patrol on Canada Day between Port Franks and St. Josephs. Numerous vessel checks were completed and the overwhelming majority of vessels and operators were found to be in compliance. One vessel operator was charged with failing to have enough lifejackets/personal floatation devices on board for all of his passengers. A 13-year-old was also sent into shore for operating a Personal Watercraft (PWC) without a Pleasure Craft Operators Card (PCOC) and for being under age while operating a PWC.

All in all, Huron OPP fulfilled their mission and is very pleased with the overall results of the Canada Day Long Weekend traffic safety campaign.

PEOPLE ARE STILL NOT LOCKING THEM UP

Unlocked Vehicles are Easy Targets for Thieves

(HURON COUNTY, ON) – Huron County Ontario Provincial Police (OPP) put out a plea to vehicle owners back in April of this year, we asked, **“Help Us, Help You!”** The request was straight forward; lock up your vehicle and remove the keys from your vehicle when not in use. Such a simple, effortless practice can make all the difference in reducing the number of stolen vehicles, however it seems many may have missed the message or simply just won’t change their habits.

A look at the stolen vehicle occurrences in Huron County over the last few weeks (June 1 to July 7) should get the attention of vehicle owners. There were a total of **19** stolen vehicles during this time frame, which averages out to about one stolen vehicle every other day.

Trucks seem to be the favourite vehicle to steal for thieves as 13 were stolen. Three cars, two motor-bikes and one All-Terrain Vehicle (ATV) were also stolen. Thieves weren’t too picky as to where the vehicles were stolen from as 13 were stolen from urban areas and six were taken from rural properties.

The majority of the vehicles were stolen under the cover of darkness between the hours of 9 p.m. and 6 a.m., as 15 were stolen at night, versus four taken during daylight hours.

And once again, to nobody’s surprise the statistics reinforce the message that vehicle theft is a crime of opportunity as a whopping **84%** (16 out of 19) of the stolen vehicles were left unlocked or not secured in any fashion and to make it even easier for the thieves, nearly all of the stolen vehicles had the keys left in them.

“We are asking for the public to help us reduce these opportunistic thefts. Please think twice before leaving your vehicle unlocked, with the keys readily accessible. Changing your routine, by securing your vehicle and pocketing your keys, can go a long way in preventing these thefts. Don’t take unnecessary risks. Together, with your help, we can curb the number of stolen vehicles and associated crimes. We can’t do it alone, so please Help Us, Help You”.

Stolen vehicles are just the start of the problem since these desperate thieves often use the vehicle to commit other crimes in our community such as driving dangerously, failing to stop for police, using the vehicle to transport illegal drugs and using it as a means of transportation to commit break, enter and thefts.

Not only are owners failing to lock up their vehicles they are routinely failing to remove valuables from their vehicle. Items such as power tools, electronic devices, purses, wallets, sunglasses, passports, medication and loose change are commonly stolen. If your wallet or purse is stolen not only are you out some cash but your identification is in the hands of a criminal.....needless to say, you may find yourself dealing with an identity theft nightmare.

AUTO THEFT PROTECTION TIPS

- Always lock your vehicle doors and windows.
- Never leave your keys in the vehicle or in an easily accessible area
- Never leave your vehicle unattended while it is running
- If you have a garage, use it and lock the garage as well as your vehicle inside
- Always park your vehicle in a well-lit area
- Never leave valuable objects or packages in full view. Put them in the trunk if you have to leave them in your vehicle.
- Never leave your purse or wallet in your vehicle.

BOAT THIEVES CHARGED

(SOUTH HURON & BLUEWATER, ON) – A pontoon boat, engine and trailer package valued at nearly \$105,000 has been recovered and three accused are now facing charges thanks to a call from an observant witness.

On Thursday, July 18, 2019 shortly before 10:00 p.m. Huron County Ontario Provincial Police (OPP) officers received a call from a witness that reported some suspicious activity taking place at a marine retail & service center located on Bluewater Veteran's Highway north of Grand Bend. The caller reported he observed some suspicious people hooking onto a trailer and pontoon boat after-hours at the business so he confronted them.

Upon confronting the suspects they quickly departed the business towing the boat and trailer northbound on Bluewater Veteran's Highway. Simultaneously officers began patrolling for the suspect vehicle. A short while later, an OPP officer spotted the suspect vehicle and pontoon boat pulled over on Dashwood Road.

Subsequent investigation confirmed the pontoon boat & trailer were in fact just stolen from the business. As a result, the investigating officer arrested three suspects at the scene.

Jason KELL, 34 years of age from Mount Albert has been charged with Break, Enter and Commit an Indictable Offence, Possession of Property Obtained by Crime Over \$5,000 and Disobey Court Order. He remains in custody with a court appearance scheduled for July 23, 2019 at the Ontario Court of Justice – Goderich.

Joanne SCOTT, 57 years of age and Mark HANSBURY, 64 years of age both from Mount Albert have been charged with Break, Enter and Commit an Indictable Offence and Possession of Property Obtained by Crime Over \$5,000. They were both released from custody with a court appearance scheduled for August 26, 2019 at the Ontario Court of Justice – Goderich.

LICENCE SEIZED AND VEHICLE IMPOUNDED

(SOUTH HURON, ON) - A 23-year-old from Scarborough had to find another ride back home after his vehicle was impounded and his driver's licence was seized last week by Huron County Ontario Provincial Police (OPP).

On Friday, July 19, 2019 at approximately 7:30 p.m. a Huron OPP officer was conducting stationary RADAR patrol on Dashwood Road at Parr Line when a hatchback was observed travelling westbound on Dashwood Road at a high rate of speed. The officer activated the RADAR device and measured the speed of the target vehicle at a rate in excess of 60 km/h over the 90 km/h posted speed limit.

A traffic stop ensued and the driver was subsequently charged. Nicholas OLM, a 23-year-old from Scarborough has been charged with Drive Motor Vehicle Perform a Stunt – Speeding by 50 km/h or more. He will now have to attend Provincial Offences Court in Goderich on September 17, 2019 to answer to the charge. His driver's licence was automatically suspended for seven days and his vehicle was also impounded for a week.

PICKUP TRUCK STOLEN

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) are currently investigating the overnight theft of a company pickup truck stolen from a construction site located on Mount Carmel Drive.

Sometime between 7:00 p.m. on July 25, 2019 and 5:00 a.m. this morning someone ventured onto the construction site and entered into the unlocked pickup truck. The thieves also rummaged through two other vehicles that were left insecure.

The thieves found the keys to the truck and subsequently departed the property in a grey, 2007 Chevrolet Silverado, 1500 crew cab. The pickup truck had an attached silver topper with multiple dents located on the rear driver's side quarter panel. Inside the truck were numerous tools, a construction hat and two sets of overalls.

The truck is valued at approximately \$6,000.

OFFICER ASSAULTED

(SOUTH HURON, ON) – A 33-year-old from Exeter should have stuck with playing baseball with his bat rather than using it as a weapon against an officer.

On Friday, July 26, 2019 at approximately 9:06 p.m. Huron County Ontario Provincial Police (OPP) officers responded to a call on Carling Street about someone letting off firecrackers in the neighbourhood. Upon arrival officers checked around however no signs of anyone letting off firecrackers were observed.

Upon receiving the initial call from the complainant officers received a secondary call from the same caller. This time, the caller began expressing his concerns with various unrelated issues. Upon locating the caller's residence officers attempted to speak with the caller however he refused to speak with the officers. A call was made into the residence and the caller was asked to come out and speak with the officers so they could ascertain further details.

The resident then immediately opened his door and charged out of his residence at the two responding officers. The accused then swung a baseball bat at the one officer striking the officer in the arm causing a minor injury.

The accused then retreated into his residence and barricaded himself inside. Additional resources were called to the scene and approximately an hour and a half later the accused surrendered to police without incident.

Kevin FOWLES, 33 years of age, from Exeter has been charged with Assault a Peace Officer with a Weapon. He has since been released from custody with a court appearance scheduled for August 12, 2019 at the Ontario Court of Justice – Goderich.

PICKUP TRUCK STOLEN FROM HURON PARK

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) officers are investigating a recent theft of a pickup truck that was stolen from a business located on Canada Avenue in Huron Park.

Investigators have been able to determine the truck was stolen at approximately 2:40 a.m. on Saturday, July 27, 2019. Two suspects arrived at the business on a black sport-style motorcycle and moments later the suspects left. One suspect left on the motorcycle and one left in the pickup.

The stolen truck is described as a white, 2004 Chevrolet Silverado crew cab. A value for the truck is not available at this time.

BREAK, ENTER AND THEFT OF TOOLS

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) officers are investigating a break, enter and theft of tools that occurred earlier this month near Mount Carmel.

Sometime between 3:00 p.m. on July 18, 2019 and 8:00 a.m. on July 24, 2019 unknown persons attended a farm property located on Mount Carmel Drive east of Mount Carmel. Once at the farm they entered into a storage/shop area through an open overhead door and proceeded to steal tools valued in excess of \$5,000.

Some of the stolen items consisted of several Snap-on brand tools including impact wrenches, socket sets, ratchets and a booster pack. Also stolen were two Husqvarna chainsaws, a Stihl gas powered cut-off saw, a Milwaukee hammer drill, two hydraulic jacks and a Remington brand pellet gun.

Once the tools were loaded up the thieves departed the scene.

SENIOR SCAMMED OUT OF \$8,000

(HURON COUNTY, ON) – A scammer has set back a Central Huron resident \$8,000 after the victim fell for a deceptive Google Play gift card scam.

It all started when the victim in this matter received a call from someone pretending to work for her bank. She was informed by this supposed bank employee her bank account had been hacked and \$600 had been stolen from her account and wired to India. The scammer then pretended to transfer her call to the "fraud department". She was then informed the bank would contact the wire transfer service on her behalf and would try to get her money back for her. She received a return call later in the day to advise her the bank was successful in getting her money back plus an extra thousand dollars.

The victim was then instructed she had to repay the wire transfer service company by purchasing Google Play cards. The victim ultimately complied with the scammer's requests and purchased a total of \$8,000 worth of Google Play gift cards. The scammer led the victim to believe the bank had provided her money to make these purchases. The scammer gained access to her bank account and funds were shifted from her line of credit into her chequing account. Thinking money had been transferred into her account the victim went along with the scam. Once the authorization codes were supplied from the gift cards the scam was now complete.

The scammer called back a few days later requesting the victim purchase an additional \$6,000 worth of cards, however this time the victim declined and reported the matter to her bank.

Gift card scams are very popular because they continue to work. Here are some things you should know. Scammers will use different ways to trick people into providing them with the authorization codes. They may ask for the gift cards in exchange to pay taxes, bail money, debt collection or for physical items.

Remember, you can only use Google Play gift cards to make purchases like apps and music on Google Play.

Protect Yourself from Gift Card Scams

- Never use Google Play gift cards to pay for anything outside of Google Play
- Never share the code on the back of the gift card. Once you provide the code, the scammer can start making purchases. It will likely be spent before your contact Google, your bank or the police.

The best thing to do if you receive an unsolicited call is to hang up the phone. If you have any doubt at all, call a trusted family member, your bank directly or the police and ask them about it.

Don't become a statistic. Fraud is a multi-billion dollar enterprise that will only stop when the scammers stop getting money, banking information or personal information.

LONG WEEKEND TRAFFIC FATALITIES, 8,000+ CHARGES KEPT OPP BUSY

Two Off-Road Vehicle Deaths have OPP Issuing Safety Message

(HURON COUNTY, ON) – Thousands of drivers throughout the province chose to be issued traffic citations rather than be the safe motorists the Ontario Provincial Police (OPP) had hoped they would be over the Civic Day Long Weekend.

Despite letting drivers know about their Move Over Campaign ahead of the long weekend, the OPP laid **355** charges against drivers who were in a position, but failed to slow down and, when safe to do so, change lanes for emergency vehicles and tow trucks parked on the roadside.

Aggressive drivers dominated the traffic offence categories, with officers laying **4,837** speeding charges and **148** stunt driving/racing charges. Speed violations accounted for more than half of the **8,377** traffic charges issued by the OPP over the long weekend.

Sadly, two men, aged 29 and 37 were killed in separate motor vehicle collisions on OPP-patrolled roads. Driver inattention and excessive speed were reported as the primary causes in the incidents.

The weekend was cut short for two other men, aged 27 and 41, who were killed in separate off-road vehicle collisions. The OPP reported loss of control and excessive speed as primary causes and alcohol being a factor in one of the incidents.

Locally, Huron County OPP officers laid a total of **72** driving related charges over the Civic Day Long Weekend Campaign. The bulk of the charges were for speeding (47), other moving violations (19), two Compulsory Automobile Insurance Act charges, one Stunt Driving charge, one Seatbelt violation and one criminal charge for Impaired Driving was laid.

Huron OPP officers also investigated 13 motor vehicle collisions over the weekend. All but one were property damage collisions. One collision that took place on Friday, August 2nd at the intersection of Hern Line and Thames Road involved minor injuries to one passenger.

With many weeks of summer remaining, the OPP is reporting that loss of control and excessive speed were contributing factors in nine of this year's 12 off-road vehicle deaths. More than half of the deceased were not wearing a helmet and alcohol/drug use was a factor in at least three of the incidents.

The OPP is encouraging Ontarians to exercise the positive influence they can have on family members who drive off-road vehicles. Remind them that those who do not wear a helmet, drive under the influence of alcohol/drugs and are not mindful of speed are the off-roaders who are least likely to make it home safely to their families at the end of their ride.

JEEP LIBERTY STOLEN - EXETER

(SOUTH HURON, ON) – Huron County Ontario Provincial Police (OPP) officers are investigating the recent theft of a Jeep Liberty that was stolen from a residence located on Riverside Drive in South Huron.

Investigators have been able to determine the truck was stolen sometime between 9:00 p.m. on August 18 and 9:00 a.m. on Monday, August 19, 2019. The vehicle had been left in the laneway unlocked and

with the keys in the console. Additionally, some debit cards and a driver's licence were left behind in the vehicle.

The stolen vehicle is described as a green, 2007 Jeep Liberty. A value for the stolen vehicle is not available at this time.

Set one was described as General Grabber HTS with a tire size of P275/60R20.

Set two was described as General Grabber HTS with a tire size of P275/55R20.

Set three was described as Goodyear Wrangler RSA with a tire size of P275/55R20.

The rims and tires are valued at over \$18,000.

HURON OPP REMIND EVERYONE THAT IT'S BACK TO SCHOOL TIME

(HURON COUNTY, ON) - The Ontario Provincial Police (OPP) Huron County Detachment would like to take this opportunity to remind everyone that children have returned to school. As with years past, it is a busy time for everyone settling back into the routine of school time. So let's make this school year a safe time of year for everyone.

Parents please talk with your children about being safe when going and coming from school.

Listed are a few reminders.

- Cyclists under the age of 18 are required by law to wear a properly fitted and fastened bike helmet. Cyclists must obey the same rules of the road that other vehicles do and always keep your eyes and ears open as sometimes other vehicles may not see you.
- Pedestrians should stay on sidewalks and where there are none, they should be walking on the left side of the road as far off onto the shoulder as possible facing traffic. Both pedestrians and cyclists should make use of the crossing guards who will be returning to their posts to help our children get safely across the streets.
- Drivers are reminded that the traffic volume will increase, and your commute time may be affected by the bus routes. Just a reminder that the registered owner of a vehicle can be charged if that vehicle is identified as one that fails to stop for a school bus when its overhead red signal lights are flashing.

Huron County OPP will be on patrol with all available units patrolling the roads with special attention being directed at school zones and bus stops.

The fines and penalties for endangering pedestrians on roadways throughout Ontario increased as of September 1, 2018. This includes higher fines and more demerit points for drivers who fail to yield to pedestrians at crossovers, school crossings and crosswalks with a school guard present.

- Failing to yield at pedestrian crosswalks, school crossings and crossovers - fine up to \$1,000 and four demerit points
- Running a red light - Fine up to \$1,000 and three demerit points
- Failure to stop for a school bus - Fine up to \$2,000 for a first offence, six demerit points and possible jail time for up to six months.
- Careless Driving - Fine up to \$2,000, six demerit points, possible jail time of six months and a driver's licence suspension of up to two years

"It is now back-to-school time. The safety of our children boarding and exiting school buses relies on drivers paying attention and watching for the flashing lights. Drivers need to remember that summer is now over. The buses are back and, hopefully, the consideration by drivers for the children aboard these school buses is back as well." - Staff Sergeant David Sinko, Operations Manager, Huron County OPP.

OPP WARN RESIDENTS ABOUT AN EXTORTION SCAM

(HURON COUNTY, ON) - On August 14, 2019, at approximately 2:00 p.m., the Ontario Provincial Police (OPP) Huron County Detachment investigated an extortion scam after being contacted by a concerned member of the public.

It was determined that the victim had been contacted by someone who claimed that the victim's accounts had been hacked and that they were in possession of sensitive information. The scammer also alleged that victim had visited adult websites and if they refused to forward a quantity of money, pictures and video of the adult pornography sites visited would be forwarded to everyone in their contact list.

No money was forwarded and no personal information was provided. The victim realized that this was a scam trying to extort money and immediately contacted police. These types of messages are commonly known as scareware and are designed to create anxiety and complete shock for the victim resulting in the person sending money.

If you receive one of these messages, please be aware that this is a scam. If you've received a phone call or email of this nature or you have been "locked out" of your computer, this is an indication that your computer system may have been infected with malware and you will need to take steps to address the problem.

Tips to protect yourself:

- Never download anti-virus software from a pop-up or link sent to you through an e-mail
- Update your anti-virus software often and scan your computer for viruses regularly
- Don't click on links or attachments in e-mails sent to you by someone you don't know
- Turn on your browser's pop-up blocking feature
- Never click on a pop up that claims your computer has a virus.
