Drainage Act, R.S.O. 1990, c. D.17, subs. 45(1)

Drainage By-law Number 67-2019

A by-law to provide for a drainage works in the Municipality of South Huron
in the County of Huron.

Whereas the council of the Municipality of South Huron has procured a
report under section 4 and 78 of the *Drainage Act* for the construction and improvement
of the Tomlinson Municipal Drain 2019 drain;

And whereas the report dated 2019/07/24 has been authored by W.J. Dietrich P. Eng.
and the attached report forms part of this by-law;

And whereas the estimated total cost of the drainage work is \$811,200.00 ;

And whereas \$375,300.00 is the amount to be contributed by the Municipality
of South Huron for the drainage works;

1. AUTHORIZATION

The attached report is adopted and the drainage works is authorized and shall be completed as specified in the report.

2. BORROWING

The Corporation of the Municipality of South Huron
may borrow on the credit of the Corporation the amount of \$811,200.00 being the amount necessary for
the construction and improvement of the drainage works.

This project will NOT be debentured.

"Tomlinson Municipal Drain 2019 _____ by-law".
