# 1. <u>Meeting Called to Order</u>

Mayor Finch called the meeting to order at 5:30 p.m and noted that CAO Dan Best is attending and participating in the meeting by telephone.

4. <u>Nustadia Recreation Inc. - Presentation - Condition Assessment and Master Plan</u> for Community Recreational Facilities Study

Mr. Pavao reviewed the Condition Assessment and Master Plan for Community Recreation Facilities Study.

That the Committee of the Whole recommend that Council provide direction to staff to contact Perth South regarding submitting a joint application to the "Investing in Canada Infrastructure Program" for the Kirkton Pool.

Mr. Pavao noted that the concept drawings included in the report are just a way to explore initial ideas for designs and not the actual design drawings. The Committee discussed the design build in detail. The Committee noted that this is a preliminary report due to the grant application deadline and Mr. Pavao confirmed that an update of the Master Recreation Plan will be provided when complete.

CAO Best noted that the grant application process is very competitive and South Huron needs to make a good application in order to be successful.

That there is another general space in the design comprised of 15% of the total assigned building space.
