4. Staff Reports

4.1 Asset Management - Budget 2020 - Presentation M. McBride, Financial Services Officer

M. McBride, Financial Services Officer presented an Asset Management overview including South Huron's accomplishments for 2019, goals for 2020 and an update on legislation. Officer McBride advised that the Asset Management working group consists of the CAO D. Best, Director of Financial Services/Treasurer S. Becker, Director of Infrastructure & Development D. Giberson, herself, and on occasion assistance from the Manager of Public Works and Manager of Environmental Services.

Officer McBride noted that South Huron obtained consulting services from Hemson free of charge through the AMP it Up 2.0 provided by the Municipal Finance Officers Association to assist with preparing the asset management action plan, which is being used by the Asset Management working group to develop the 2020 and future work plans. This program will allow for additional support to help staff throughout 2020 for implementation of the asset management action plan.

- 4.2 2020 Budget Basics Presentation S. Becker, Director of Financial Services/Treasurer
 - S. Becker, Director of Financial Services/Treasurer reviewed the budget process and presented an overview of budget basics. It was noted that

2020 is a reassessment year for MPAC, market increase is phased in equally over 4 years. She advised there will be something forthcoming during Budget deliberations relating to Information Technology Initiatives to assist with Cyber Security.

Director Becker provided Council with an overview of budget pressures and tax increase considerations, which were discussed by Council along with the capital replacement reserve. Council adjusted the tax rate increase and dedicated capital levy consideration as a starting point for budget deliberations.
