Subject: Age-Friendly Community Plan 2019 Update

Recommendations:

That South Huron Council receives the report from S.Currie, Manager of Community Services titled "Age-Friendly Community Plan 2019 Update" for information.

Purpose:

Information.

Background and Analysis:

An Age-friendly community plan supports and enables older people to enjoy good health and continue to participate fully in their communities. Developed with extensive community input starting in 2016, the Municipality's Age-Friendly Community Plan was formally adopted by Council in July of 2018. The plan has guided the actions of staff and community partners for several years. The purpose of this report is to:

- A) Update Council on the status of the Age-Friendly Community Committee recruitment process;
- B) Update Council on the status of the Municipality's implementation of the Age-Friendly Community Plan; and
- C) Outline new age-friendly initiatives for implementation in 2020.

A) Age-Friendly Community Committee Recruitment

Since receiving direction from Council at the July 18, 2018 meeting (motion #375-2018), staff have twice attempted to recruit for the Age-Friendly Community Committee – once in the fall of 2018 and once in the summer of 2019. However, to date, the Municipality has been unable to attract enough interest to establish a committee. Staff recommend that a third recruitment attempt be made in the spring of 2020 at which time a number of age-friendly initiatives underway will hopefully attract greater interest.

B) Status of Age-Friendly Community Plan implementation

The summary in Appendix I identifies the plan's goals, strategic priority, status and further actions, where appropriate. These actions will form part of the 2020 staff work plan.

C) New initiatives for 2020

The following initiatives are included in the 2020 budget package for deliberation by Council.

1) Senior's Social Program

To address the issue of socially isolated seniors, staff are developing a weekly agenda for the winter of 2020 to provide opportunites for socialization, inclusion and information sharing. This work will be supported by a grant received from the province, which will cover transportation and meeting costs.

These weekly get togethers will see participants receive training (i.e., how to use the MOSH website to access information, OPP presentation on how to recognize telephone/online fraud scams, etc), listen to guest speakers, play games, and share stories via social media - ideally with the assistance of youth 'buddies'. Local paternships are being sought to support this program.

2) Recreational Urban Polling

To enhance recreational opportunities for seniors, staff are piloting an Urban Polling Program in South Huron. This would involve the purchase of a dozen sets of walking poles to be distributed to communities in South Huron for free rental on a weekly basis. Walking poles assist individuals with mobility/stability issues to increase their confidence and be more active. These poles are strong, lightweight, and adjustable in height.

3) Birding Week at the Exeter Sewage Lagoon.

To coincide with spring migration, staff are organizing a Birding Week during the second week of May to engage seniors in a new, low-impact outdoor activity. The added benefit of this initiative is it can also be marketed as a broader tourism event to attract eco-tourists/naturalists to our community – birding is a large industry in other Southwestern Ontario municipalities (i.e., Leamington, Saugeen Shores). The Exeter Lagoon is a very important bird watching asset in our municipality.

4) Senior's Initiative of the Year Award

Staff are developing a Terms of Reference for an annual award recognizing community initiatives that enable older people to enjoy good health and continue to participate fully in their communities.

Included in the 2020 budget package for Council's deliberation, the new initiatives in this report are estimated to cost the following amounts:

- 1. Senior's Socials: Province of Ontario grant of \$10,800 + MOSH contribution of \$1,000 = \$11,800 Total
- 2. Urban Polling: \$1,400
- 3. Birding Week: \$700
- 4. Seniors Initiative of the Year Award: \$500

Council previously directed staff to establish an Age-Friendly Community Committee, and \$600 is being requested as part of the 2020 budget to support this committee, once established.
