Recommendations:

That South Huron Council receives the report from D. Giberson, Director of Infrastructure and Development and Shawn Young, Manager of Environmental Services Re: South Huron Landfill Site – Recycling agricultural bale wrap.

Purpose:

Background and Analysis:

Agricultural bale wrap and silage tarps have not been accepted at South Huron Landfill Site since 2017. Since that time we have encouraged farmers and businesses to recycle this material and have provided information from a local company, Switch Energy Corporation, regarding a recycling option.

Switch Energy Corporation is located on Highway #8 near Clinton and will deal directly with the farmer or business to pick up agricultural bale wrap and silage tarps from their farm or place of business. Switch Energy will send collection bags to the farmer or business and arrange to pick up the bagged bale wrap at their farm or business. Switch Energy offers this service for a pay-as-you-go fee. For each new pouch of 15 collection bags, customers receive by mail an invoice directly from Switch Energy. Their fee entitles customers to continue to receive farm/business pick-up from Switch Energy. Tied bags are not to exceed 40 pounds and payments are made directly to Switch Energy Corporation.

This is a good option for the Municipality, as we are not involved in the recycling process and do not incur and costs. Not only is this good for the environment, the Municipality benefits from this waste diversion by extending the life of the landfill site.
