### **Recommendations:**

**That** South Huron Council receive the report from D. Giberson, Director of Infrastructure and Development and S. Young, Manager of Environmental Services RE: Tender Results for Trailer Mounted Valve Maintenance Unit AND;

**That** South Huron Council accept the tender received from the WACHS Canada Limited and authorize award of a contract for the supply of a Trailer Mounted Valve Maintenance Unit in the amount of \$87,520.00 (plus HST).

### **Purpose:**

The purpose of this report is to notify Council of the results of the tender for the supply of the Trailer Mounted Valve Maintenance Unit and to recommend award of a contract to the single bidder.

## **Background and Analysis:**

The tender for the supply of the Trailer Mounted Valve Maintenance Unit was advertised on the Bids & Tenders on June 15, 2020.

Tenders closed on July 15, 2020 at 2:00pm and one (1) tender was received by the Municipality. The single tender was opened by Don Giberson, Director of Infrastructure and Development, in the presence of Mayor Finch and Maggie McBride, Financial Services Officer. This was not a public opening due to the COVID19 pandemic. Tender receiving/opening protocols were amended and additional precautions were taken to ensure staff, public, contractors and project engineer were safe and protected.

The following is the tender results:

The tender was checked and found to be complete and in conformance with the specifications. Receipt of a single tender was not unexpected for this item, as it is a highly specialized piece of equipment, with few suppliers in this market.

## **Financial Impact:**

Costs associated with the supply of the Trailer Mounted Valve Maintenance Unit is included in the approved 2020 Capital Budget. The tendered price was originally over budget, mostly due to the increase in the exchange rate, as this is a USA product and due to production delays as a result of COVID19 pandemic. Accordingly, credits were negotiated with the vender.

The vender offered a credit of \$3,170 for eliminating the optional submersible pump and a credit of \$4,485 for not supplying a new hand held controller, as the controller had been recently replaced on the existing unit. Both credits were accepted and the final price reflects these credits.

A financial analysis of the tender received from the single bidder was carried out and is summarized as follows:
