# **Purpose:**

### **Background and Analysis:**

The tender for Supply-Mix-Stockpile of Winter Sand was advertised on the Bids and Tenders web site, in accordance with section 9(b) of the Procurement By-Law#33-2017. Bids and Tenders is an on-line procurement service for public sector tenders, quotations and RFPs.

The Supply-Mix-Stockpile of Winter Sand tender was posted on Bids and Tenders on Monday June 29, 2020. Tenders closed on Monday July 27, 2020 at 2:00pm and three (3) tenders were received by the Municipality. Tenders were opened by Megan Goss, Manager of Public Works, in the presence of Mayor Finch and Maggie McBride, Financial Services Officer.

The budget for winter sand and salt is \$110,000, and the actual year to date expenditures are \$35,407. This represents the sand and salt expense from January – April 2020. There is a potential that we may need to bring in more material, dependent on weather events. It should be noted that any surplus from budget to actual is allocated to the winter maintenance reserve by policy.
