6. <u>O.P.P. Report</u>

- Detailed report for June was distributed prior to the meeting for review and to allow for effective discussion at the Board meeting
- Inspector Jason Younan provided a comprehensive overview and explanation of the report
- Noted that property crimes may increase as COVID guideline relax
- There has been a growing interest in copper wire again unoccupied residences have been entered to gain access
- Ironwood Golf Course was broken into during the month
- Internet fraud continues any groups or organizations wishing presentations by the OPP are welcome to contact the OPP or the Board Chair – presentations can proceed in a COVID friendly manner
- Drug crimes are far and wide, and readily available throughout the County homelessness continues and is sometimes associated with mental health concerns and/or drug usage
- RIDE programs continue
- Focus patrols 5 hours were dedicated to the Shipka speeding concern speed signs that have been installed are assisting to reduce speeding in this area
- Fireworks provided an update to the Board surrounding this ongoing issue
- Illegal activities have been occurring in public washrooms at Victoria Park and the Splash Zone in Exeter, creating a safety hazard for the public and municipal staff
- Automatic door locks, on a timer system were installed previously to address this problem in the evening hours
- Moving forward, washroom access will only be allowed during peak program times 9 am to 8 pm
- OPP have increased patrols surrounding this issue
- Inspector Younan spent some time in the areas of concern and noted that WIFI is offered free of charge in the Splash Zone/MacNaughton Park area this may contribute to individuals congregating in these areas, as well as to increased drug usage
- Installation of security cameras may assist in monitoring the activities of the area and are relatively inexpensive to purchase

- Increased lighting in the areas of concern may discourage individuals from partaking in illegal activities
- For the safety of the community, should you observe any unlawful actions, please report to the OPP immediately
- Calls for service billing summary report mental health calls are slightly increasing which has been the trend across the County
- Calls for service are down 1,000 hours from this year at same time
- Officers will be patrolling the Crediton detour route as bridge construction continues proactive policing
- Inspector Younan noted that Superintendent Lisa Darling will be in attendance at a future Board meeting
- Chair Dietrich thanked Inspector Younan for providing the overview and explanation to the Board
