### **Background and Analysis:**

For the past two seasons, COVID -19 has had a significant impact on operations of our pool facilities and programming.

South Huron Community Services was only able to operate both swimming pools on a bi-weekly basis for the 2021 season due to limited lifeguard availability. This report will show programs offered, the number of users as well as locations where users registered from.

#### Aqua Fit - \$3.00 per class

Tuesdays & Thursdays, 7:45 PM – 8:30 PM 16 sessions in Exeter 8 sessions in Kirkton Woodham Capped at 10 enrollees in Exeter & 12 in Kirkton Woodham 229 out of 252 spaces utilized throughout the summer (91% program utilization)

#### Lane Swim - \$3.00 per swim

Tuesdays & Thursdays, 7:45 PM – 8:30 PM Runs at the same time as aqua fit, capped at 6 enrollees per session 73 out of 96 spaces utilized throughout the summer (76% program utilization)

#### Swim Team - \$60.00 per season

Monday & Wednesdays, 3:30 PM - 4:00 PM (JR Swim Team) 8 out of 8 spaces filled, JR Swim Team (100% program utilization) Tuesday & Thursday, 3:30 PM - 4:0 0PM (SR Swim Team) 11 out of 11 spaces filled, SR Swim Team (100% program utilization)

#### **Bronze Medallion & Bronze Course - \$125.00**

2 week program, 1:00 PM - 4:00 PM, July 5<sup>th</sup> - July 16<sup>th</sup> (Monday - Friday) 16 out of 16 spaces filled (100 % program utilization)

## Public Swimming - \$3.00 per swim

Saturday & Sunday, 1:30 PM - 2:30 PM & 2:30 PM - 3:30 PM Monday - Friday, 1:00 PM - 2:00 PM & 2:00 PM - 3:00 PM 185 public swimming sessions offered 2492 enrollments

#### **Swimming Lesson Summary**

Due to COVID-19 and availability & experience of guards, only private and semi-private lessons (capped at 3 people per lesson) were offered. Classes were 30 minutes in length with 15 minutes in between class times. Lessons were one week in duration and ran from Monday – Friday.

It should be noted that the Recreation Facility Master Plan Facility Study conducted in 2019, identified the following for the Kirkton-Woodham Pool:

- Built in 1973 current condition is fair
- Original building construction fair to good quality
- Shared ownership agreement 50% operating & capital exp.
- Capital investment next 5 to 10 years \$1.5 to \$2m
- Good investment if existing partnership is in place

### **Operational Considerations:**

- Moving forward, the issue of Staffing will continue to be a challenge.
  Recruitment strategies will begin in January for the upcoming 2022 season.
- Role clarity needs to be addressed regarding the role of the Committee and Perth South. It needs to be recognized that South Huron is the administering municipality and that staff are employees of South Huron.
- The operation of two part-time pools is a drain on resources and staff.
   If Staffing complement is only sufficient for one pool, only one pool
   should be opened. Given investment and operational considerations,
   from a staff perspective, the Exeter and District Pool would be the
   priority to be open in such a scenario.
