### **CHARGES LAID IN STORAGE FACILITY BREAK-IN**

**(SOUTH HURON, ON)** – Huron County Ontario Provincial Police (OPP) has laid charges against four individuals following a break, enter and theft investigation at an Exeter business.

On January 4, 2022 Huron County OPP officers were notified of a break, enter and theft that took place at a storage facility in Exeter. Officers attended the scene and following some investigation officers were able to identify four suspects that were responsible for stealing numerous items from the units.

On January 5, 2022 Huron County OPP arrested two of the suspects in Morris-Turnberry on a traffic stop. While searching the suspect's vehicle, officers located and seized suspected fentanyl & methamphetamine, a prohibited knife and a prohibited weapon. Police also located and seized a stolen dirt bike that was contained inside a trailer being towed by the suspects.

A third suspect was arrested by Huron County OPP in Clinton on January 11, 2022.

The fourth suspect remains wanted by Huron County OPP.

Sandy BAKER, 36 years of age from Wingham has been charged with: Break & Enter, Theft Under \$5,000, Possession of a Schedule I Substance – Methamphetamine, Possession of a Schedule I Substance – Fentanyl, Unauthorized Possession of Weapons in a Vehicle (Flick Knife, Animal Spray, Arrow Shotgun & Butterfly Knife), Possession of a Weapon for a Dangerous Purpose and Possession of Property Obtained by Crime Under \$5,000. The accused has since been released from custody with a court appearance scheduled for February 7, 2022 at the Ontario Court of Justice – Goderich.

Kelsey CHAPMAN, 21 years of age from Clinton has been charged with: Break & Enter, Theft Under \$5,000, Possession of a Schedule I Substance – Fentanyl and Unauthorized Possession of Weapons in a Vehicle (Flick Knife & Animal Spray). The accused remains in custody with a court appearance scheduled for January 20, 2022 at the Ontario Court of Justice – Goderich.

Nollan WHITFIELD, 36 years of age from Wingham has been charged with: Break & Enter, Theft Under \$5,000, Fail to Comply with Probation Order and Breach of Recognizance. The accused has since been released from custody with a court appearance scheduled for February 28, 2022 at the Ontario Court of Justice – Goderich.

### **OPP DRUG WARRANT EXECUTED IN DASHWOOD**

*Over \$100,000 Worth of Fentanyl Seized*

**(SOUTH HURON, ON)** – A drug trafficking investigation conducted by the Huron-Perth Ontario Provincial Police (OPP) Community Street Crimes Unit (CSCU) has culminated this week in a major seizure of Fentanyl and other controlled drugs & weapons.

On Tuesday, January 18, 2022 members from the Huron-Perth OPP Community Street Crimes Unit (CSCU), Huron County OPP Detachment, OPP Tactics and Rescue Unit (TRU), West Region Emergency Response Team (ERT) and Canine executed a search warrant at a residence located on Centre Street in Dashwood.

As a result of the execution of the search warrant, police seized large quantities of suspected Fentanyl, Methamphetamine, Heroin, Cocaine & Psilocybin (Magic Mushrooms).

The combined estimated street value of the seized controlled substances is **\$110,928**.

In addition to the seized controlled substances, police also seized offence related property consisting of drug trafficking paraphernalia, a pill press, a cell phone and digital scales. Police also seized a .22 calibre rifle, a pellet gun, four imitation hand guns, a push dagger knife and stolen property consisting of an All-Terrain Vehicle (ATV), a band saw and a stolen street sign.

**Please note:** An arrest warrant is currently being sought for the suspect in this case. An update will be provided when the suspect is taken into custody.

**RIMS & TIRES STOLEN**  
*Arrest Made & Charges Laid*

**(SOUTH HURON, ON)** – Huron County Ontario Provincial Police (OPP) officers, including members from the Huron-Perth OPP Community Street Crimes Unit (CSCU) have arrested and laid charges in connection with some recent theft of rims and catalytic converters from Exeter.

As a result of some police investigation officers were able to recover a set of stolen custom rims and tires along with 18 stolen catalytic converters. Additionally, a suspect was identified and police were able to make an arrest on January 6, 2021.

Travis DAVIS, 32 years of age, from South Huron has been charged with two counts of Possession of Property Obtained by Crime Under \$5,000.

**THIEF ARRESTED AFTER SWAPPING STOLEN VEHICLES**

**(SOUTH HURON, ON)** – Huron County Ontario Provincial Police (OPP) has charged a Tillsonburg resident with Theft following an arrest this past week in the city of London.

On January 31, 2022 Huron OPP officers responded to a business located on Main Street North in Exeter to investigate a report of a stolen pickup truck. Through the use of video surveillance investigators learned the suspects arrived at the business in a stolen car out of Oxford County. The suspects then entered into an unlocked pickup truck and took off in both vehicles. The stolen car was later found abandoned in a parking lot located on McConnell Street in Exeter.

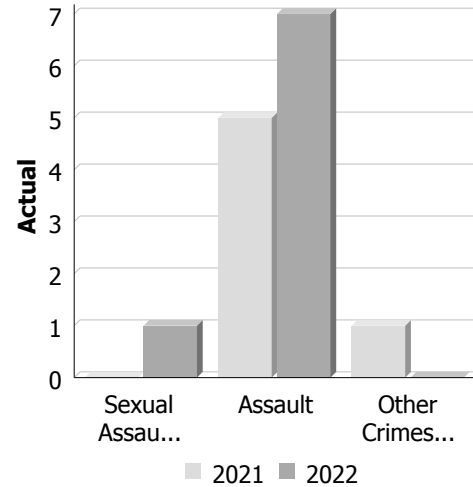
Later that afternoon officers from the Repeat Offender Parole Enforcement (ROPE) Team and London Police Service located the stolen pickup truck and two suspects.

Nathan MARTIN, 34 years of age from Tillsonburg has since been charged with Theft of Motor Vehicle and Operation While Prohibited. The accused has since been released from custody with a court appearance scheduled for March 14, 2022 at the Ontario Court of Justice – Goderich.

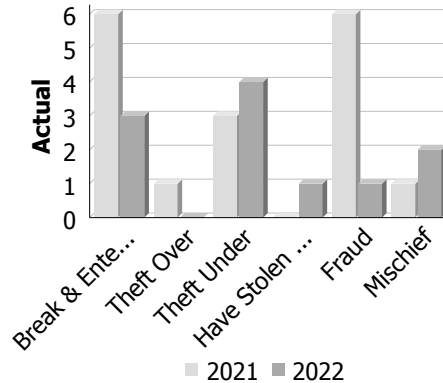

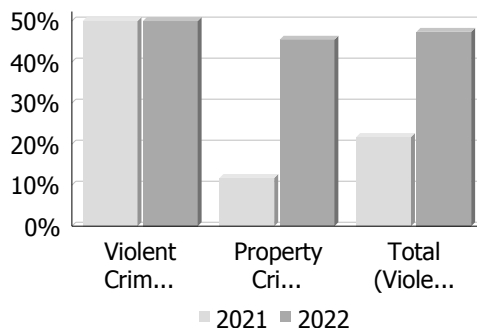

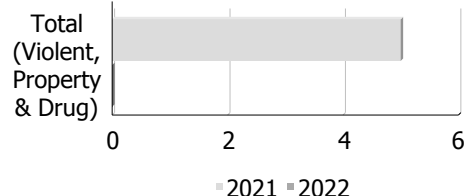
